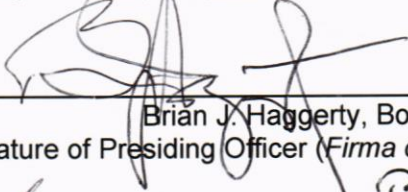

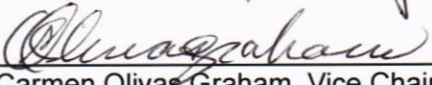
The President of the College is directed to take all steps necessary to conduct the election in

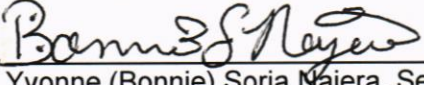

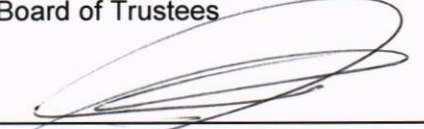

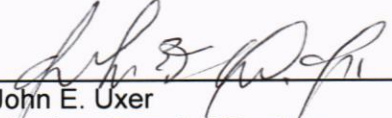
