RESOLUTION

A RESOLUTION OF THE TOWN OF CLINT, TEXAS ORDERING A GENERAL ELECTION AND A SPECIAL ELECTION BY THE QUALIFIED VOTERS OF THE TOWN OF CLINT, TEXAS, TO BE HELD ON NOVEMBER 4, 2025, FOR THE PURPOSE OF ELECTING THREE COUNCIL MEMBERS FOR FULL TERMS IN THE GENERAL ELECTION AND ONE COUNCIL MEMBER TO FILL A VACANCY IN THE SPECIAL ELECTION.

- WHEREAS, the City Council of the Town of Clint, Texas ("Town"), has determined that a general election is required on November 4, 2025, for the election of three (3) Council Members to serve two-year terms; and
- WHEREAS, a special election is also necessary on the same date to fill a vacancy in the office of one Council Member for the remainder of an unexpired term; and
- WHEREAS, pursuant to the Texas Election Code Sections 3.004, 3.005, and 41.001, the City Council desires to call and order said General and Special Election to be conducted jointly with El Paso County.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE TOWN OF CLINT:

- That a General Election and Special Election shall be held on Tuesday, November 4, 2025, for the purpose of electing three (3) City Council Members for full two-year (2) terms and one (1) City Council Member to fill an unexpired term in the Special Election.
- SECTION 2. That the Town Clerk, in coordination with the El Paso County Elections Administrator, shall prepare the ballots, designate ballot positions, and cause all required notices and postings to occur in accordance with the Texas Election Code.
- SECTION 3. That candidates must file a sworn application for a place on the ballot in accordance with state law. Applications for a place on the ballot must be filed no earlier than July 19, 2025, and no later than August 18, 2025, at 5:00 p.m.
- SECTION 4. That polls on Election Day shall be open from 7:00 a.m. to 7:00 p.m. on November 04, 2025, and all qualified voters of the Town may vote for all positions.
- SECTION 5. That the El Paso County Elections Administrator shall serve as the Early Voting Clerk. Early voting by personal appearance shall be conducted at locations

determined by the Elections Administrator, with the main early voting location designated as 500 E. San Antonio, El Paso, Texas 79901.

- SECTION 6. That early voting will be held from Monday, October 20, 2025, through Friday, October 31, 2025, including weekend voting if ordered by the Elections Administrator. The Town Clerk shall provide notice of early voting dates, hours, and locations.
- SECTION 7. That applications for ballot by mail shall be submitted to the Early Voting Clerk: 500 E. San Antonio, Lower Level, Ste. L115, El Paso, TX 79901, or by email to ballotrequests@epcounty.com no later than the close of business on October 24, 2025.
- SECTION 8. That the candidate receiving the most votes for each position shall be declared elected. In the event of a tie, the procedures under Section 2.002 of the Texas Election Code shall be followed.

SECTION 9. That this Resolution constitutes the official proclamation ordering the elections.
